(The fixtures cost \$1,553.22 and installation cost \$1989.00 for a Total cost \$3,543.22) **To those who live in buildings 6, 7 and 10 - PLEASE test that your lights actually do work. If not, please notify us so we can take the proper corrective steps.** 

#### Landscaping:

- New trees are on the schedule for Spring planting. What species is yet to be determined.
- Even though the spruce tree by the dumpster between building 3 & 4 is clearly dead, it has not been removed because it may be under warranty.
- Greenstuff has been paid in full for our 2024 landscaping chemical applications. There is a pre-pay discount incentive for which we took advantage.

- Still waiting for an invitation to the Chicopee Safety Committee Meeting regarding fire hydrants.
- There is no new update on the new installation options from Crossroads. We are planning to present our situation to our City Councilors at an upcoming meeting.
